<p>Workshops Pat S.</p>	<p>From the evaluations received, it appears that the Sponsorship Workshop held on March 25 was very successful. There were 24 people in attendance. The three speakers presented very well and focused on the topic of sponsorship—how they found a sponsor, how they were sponsored and how they sponsor. One speaker spoke about sponsoring through the Big Book Step Study process, another spoke of her disciplined approach and the third of her more relaxed approach. It was a wonderful blend that gave everyone present the opportunity to see that there is no one “right” way and that there can be more than one successful approach.</p> <p>Of the 24 attendants, 13 completed the workshop evaluation form. Eight of the 13 currently were sponsors; approximately five were hoping to become sponsors and one felt they needed to be more committed to their program and their sponsor. The majority of the respondents came to the workshop to get information to build their confidence for sponsoring and to get guidelines and more information about sponsoring. Other general comments were that the workshop gave them a new perspective and awareness on sponsoring and the different ways of sponsoring and what was expected of a sponsor. They liked the mix of speakers (although one commented that they thought the Big Book Step Study process was too much for a newcomer), sharing in small groups and learning from each other. They also wanted more sponsorship workshops, possibly taking this format “on the road” to other parts of the state, and two people suggested having workshops on Sunday, in the afternoon and somewhere around Manchester.</p>
